Voting Eligibility

Each CIHA member aged 18 years or older, with membership fees paid in full, is entitled to one vote. Each honorary life member is entitled to one vote. One parent or guardian of a junior or Learn to Play member under 18, with membership fees paid in full, may vote on behalf of that member. A parent/guardian of a junior member may vote either on behalf of a junior or for themselves if eligible, but not both.

If you are uncertain whether you are eligible to vote, please send an email to secretary@ciha.org.nz before 17 November with your contact details asking whether you are eligible. If you are unable to attend the AGM but want to vote, you may designate a proxy who can attend the meeting and vote on your behalf. To designate a proxy, send an email to secretary@ciha.org.nz prior to the meeting commencement stating your name and the name of the person who has agreed to serve as your proxy (note that no person may serve as a proxy for more than one CIHA member).

Doors open at 1:30 pm. The meeting will start at 1:45 pm and is expected to conclude by 3:45 pm. Light refreshments will be served. If you intend to vote, please arrive as early as possible so that we can verify your eligibility and issue your ballot.
